# Smart Instrumentation Module Usage (Vendors)

- ▶ Wayne Sterling - Calibration & Telecom - **\*We have this module available – and it used to be utilized by several operating plants – but Intergraph/Hexagon changed the forms from coded forms to Infomaker (customizable) forms which made them less intuitive and less user friendly to complete. That change accelerated the migration from having calibration data in SPI to other calibration software tools.**
